Reactivating the Monterey County Medical Society Alliance

We are pleased to say that the Monterey Alliance is being reactivated. An organizational luncheon was held in late July, 2010 where Patricia O'Keefe, the spouse of a local pathologist volunteered to take the lead along with MCMS staff, Sharon Jensen who will be secretary/treasurer. Patricia, Sharon and I attended the MCM Society meeting on August 24, 2010 and presented the idea of reactivating the Alliance to the board. MCMS President Dr. John Jameson and his board members along with Med Exec Bill Parrish and his staff are in support of moving ahead and will participate in activities. Bylaws have been approved by the CMAA bylaws committee and a resolution to our CMA Board of Trustees to re-charter the MCMSA is on the agenda for this meeting. The Monterey County Medical Society Alliance (then the Auxiliary) was originally started on April 4, 1930 making it the sixth Auxiliary to be chartered in the state. It remained an active county Auxiliary/Alliance until the mid 1990's. Inspired by Dr. Valerie Barnes' enthusiasm to have an Alliance in her county again, the CMAA leaders chose Monterey to be one of the counties to focus on to help us reach our BHAG (Big Hairy Audacious Goal) of having six additional active county Alliances by 2012.
