#### Collaborative Efforts

In keeping with our goals and priorities stated in our Strategic Plan to strengthen relationships between the CMA Alliance and the CMA by interfacing more closely and intentionally, the CMAA board is working closely with CMA staff and leadership to:

- \* Define the relationship between the local Alliances and the CMA Alliance
- \* Define the relationship between the local Alliances and the CMA

(The legal relationship between the CMA and the CMA Alliance was redefined in 12/08 and is stated in the CMAA 2009-2011 Strategic Plan.)

Having a clear understanding of these relationships will enhance collaborative membership/community health promotion efforts.

The Alliance is also working with our new staff liaison, Rosanna Westmoreland, VP Marketing & Communications and her staff, to develop collaborative membership, marketing, public relations and community health promotion programs. For example, the public service announcement, "Kids in Hot Cars," developed by Ron Lopp, has just been distributed throughout California and is co-branded: "A message from the physicians and Alliance members of the California Medical Association." Supporting the medical family by developing programs for medical students, residents, spouses and partners is another important goal in our Strategic Plan. On March 15, 2010 the Alliance held a panel discussion and luncheon for the medical students at Touro College of Osteopathic Medicine centering on the various aspects of life as a member of the family of medicine. VP of Membership, Rachel Smith is including the Alliance this year in the panel discussion at CMA's Medical School Leadership Conference to be held at Davis in the fall. This further supports the Alliance/Association collaborative efforts by focusing on the benefits of belonging to organized medicine and the Alliance from the beginning of training.

# Connecting with Counties Continues

Personally connecting with county leaders and members continues to be a main focus of the CMAA Board. During my two year term as CMAA President I had the privilege and pleasure of visiting each of our county Alliances at least three times attending board meetings fundraisers and other special events. I was also able to attend many medical society meetings and functions throughout the state. Our current board will continue to have a presence at the county level. We will continue to build personal relationships with our local members and county leaders and to work closely with the local medical society staff and physician leadership.

We are pleased to report that plans are in the works to reestablish the Alliance in Monterey County. Special thanks to our own CMA Board of Trustee member, Dr. E. Valerie Barnes, who has been instrumental in making this happen.
